Travis Gordon, DO, MSc, FAAO is an Assistant Professor of Osteopathic Manipulative Medicine and Medical Director of Yucatán, Mexico for MSUCOM where he leads international educational programs, research and collaborations. He has board certifications in Family Medicine and Neuromusculoskeletal Medicine and holds a Masters degree in Humanistic Psychotherapy. He endeavors to expand global osteopathic recognition and dedicate his career to bridging the knowledge gap between osteopathy and psychology in their respective mind-body approaches to understand Dr. Still's concept of unity in Body, Mind, and Spirit.

Course Description

This course aims to build upon our existing understanding of anatomy and physiology through a more complete perspective to rediscover what was always in front of our eyes and under our hands: emotion. We will explore the dual nature of emotion in which it manifests itself in psyche and soma as one integral, simultaneous, unconscious process. Reichian concepts of somatic psychology will be explored as a road map to understand common strain patterns and medical diagnoses, emphasizing the emotional basis for their existence. Specific techniques to treat emotion-based strain patterns will be explored with a focus on non-physical trauma as a principle cause of pathology, creating a general shift in perspective from pathophysiology to "treating the health", as Dr. Still taught.

Course Objectives

- Understand specific physiologic mechanisms responsible for the interplay between emotions and the somatic system
- Describe differences between the conscious and unconscious with examples that pertain to the somatic system
- Comprehend basic concepts of Gestalt therapy as they relate to osteopathic principles and be able to effectively use them during medical interview, diagnosis and treatment
- Recognize the five "characters" of somatic psychology and their manifestation from both behavioral and structural perspectives
- Perceive myofascial strain patterns typical of each character and develop personalized treatment plans based on mind-body needs
- Relate concepts of direct and indirect osteopathic techniques to psychotherapeutic strategies
