## **Course Description**

Dr. Lossing has been using Chapman's points clinically for many years. He has discovered a unique, modified approach to effectively treat many clinical scenarios in a short period of time. Dr. Frank Chapman originally described these points in 1929 as lymphatic stasis in nerves, reflecting lymph stasis in organs. It is only in the last 5 years that is has been proven that there is sympathetic nerve fibers in lymphatic nodes! This positively confirms Dr. Chapman's theory of nearly 100 years ago.

In this course, we palpate the reflex points, evaluate whether it is active or not, evaluate the connected organ, and effectively treat the points. Each point is normally treated in about 15 seconds. The treatment result is measured with changes in mobility and motility immediately after the treatment. In other words, we can palpate the change in the target tissue.

Topics include: Clinical uses of Chapman points, history, research, facilitation, posterior points and spinal dural tension, circulation of the upper extremity, upper extremity nerve pain, cervical tension, cerebellar tension, sciatica, pelvic floor tension, evaluation and treatment of adrenal dysfunction, and a wide range of other glandular, visceral and clinical problems.

- Understand the history of Chapman
- Learn how to palpate the Chapman's Points
- Learn how to quantify the points
- Evaluate the respective tissue
- Learn how to work with the points in such a way that we can quantify the changes in the respective tissue to help with such issues as sciatic pain, arm pain, visceral and glandular dysfunction
