Manuscript Components

- ☐ Cover Letter addressed to the AAOJ Editor in Chief (upload file type: *Cover Letter*)
- ☐ Title page including author names, affiliations, and wordcount (upload file type: *Title Page*)
 - ☐ On the Title Page, review the author contributions to make sure that all authors meet all 4 criteria as delineated in ICJME recommendations below. If proposed authors do not fit all of the following criteria, they should be moved to Acknowledgments.
 1. Substantial contributions to the conception or design of the work; or the acquisition, analysis, or interpretation of data for the work;
 2. Drafting the work or revising it critically for important intellectual content;
 3. Final approval of the version to be published;
 4. Agreement to be accountable for all aspects of the work in ensuring that questions related to the accuracy or integrity of any part of the work are appropriately investigated and resolved.
 - ☐ On the Title Page, include the AI Policy acknowledgement.
 - ☐ On the Title Page, include the Public Registration information if applicable.
- ☐ Acknowledgments (upload file type: *Title Page*). For authors who don't meet the ICJME 4 criteria, upload their [Acknowledgments form](#). For the purposes of peer review, names and institutions in Acknowledgments in the manuscript should be redacted or removed from the manuscript document and uploaded as a separate file type: *Title Page*.
- ☐ Anonymized manuscript (upload file type: Manuscript) with numbered references as a references list, not endnotes or footnotes. The Reference list should be formatted according to the current edition of *AMA Manual of Style* (see [Manuscript Preparation](#)).
- ☐ Tables and figures cited sequentially in the text (e.g. *Table 1*, *Table 2* and *Figure 1*, *Figure 2*).
- ☐ For manuscripts based on survey data, a copy of the original validated survey and cover letter (upload file type: Supplementary Material).

Graphic Elements

- ☐ Graphics as original files (e.g. jpg, tiff, pdf, Excel)
- ☐ Each graphic element cited in numerical order (e.g. *Table 1*, *Table 2* and *Figure 1*, *Figure 2*) with corresponding numerical captions provided in the manuscript.
- ☐ For reprinted or adapted tables, figures, and illustrations, a full citation given with appropriate attribution.

Required Legal Documentation

Upload file type: **Title Page**. Any documentation with the author(s)' or patients' names will not pass the technical check and must be re-uploaded as *Title Page*.

- ☐ For **Case Reports** featuring a patient: a signed and dated [case patient release form](#).
- ☐ For reprinted or adapted tables, figures, or illustrations not in the public domain: copyright holders' [permission to reprint](#) in the *AAO Journal* online and photocopies of the original context.
- ☐ For photographs in which patients or photographic models are featured: signed and dated [patient-model release forms](#).
- ☐ For named sources of unpublished data and individuals listed in the "Acknowledgments" section, [written permission](#) to publish their names in the *AAOJ*.
- ☐ For authors serving in the US military, the written approval of the manuscript by the applicable armed forces, as well as military or other institutional disclaimers as required by the military/institutions.

Financial Disclosure and Conflict of Interest

- ☐ All financial and nonfinancial relationships related to the submission's subject matter have been disclosed. All disclosures should be included in the manuscript's title page. See the "Title Page" section of "[AAOJ Manuscript Preparation](#)" for examples of relationships and affiliations that must be disclosed.
 - Authors who have no financial or other relationships to disclose must indicate so on the Title Page (e.g., "Dr. Jones has no conflict of interest or financial disclosure relevant to the topic of the submitted manuscript").
